## Population and Family Life Education

# **Module Overview**

Welcome to *Population and Family Life Education*. This module, like the previous module, is designed to meet the requirements of Asian students. This module should enable you to acquire an understanding of the problems associated with population explosion and harnessing the population for developmental activities. The module lays greater emphasis on family life education. Concept and functions of family, and the role of parents vis-à-vis children in a family are discussed. The problems of adolescence, sexual maturity and ways and means for responsible living are certain other discussion points for this module.

- This module will cover the following broad areas:
- The problem of population increase, its effect on development and environment and Asian perspective of population problem
- The concept of family system, role of individual members of a family and preparation of youth for marriage and parenthood
- Transition from adolescence to adulthood, anatomy of male and female reproductive systems, concept of reproductive cycle and consequences of transition
- Concept of sex and human sexuality and the related social aspects
- Concept of value system, ethics, self-esteem and self-management

This module is divided into chapters called units. Each unit will address specific learning outcomes. The study material should help you to successfully complete your assignments as well as provide information for writing your term-end examinations.

#### Learning journal

This module *Population and Family Life Education* is divided into six units. Each unit will address one or more of the module learning outcomes.

#### Unit 1: Population

This unit highlights the consequences of increasing population on environment and development as well as theories and measures of population.

#### Unit 2: The Family

This unit discusses the concept of a family and role played by different family members.

#### Unit 3: Physical Development-male and Female

This unit introduces you the changes that take place in individuals during transition from adolescence to adulthood and their preparations for marriage and parenthood.

#### Unit 4: Human Sexuality

This unit intends to guide youth to come to terms with their own sexual awareness and identity and to help them in making the right choices when they are faced with demanding situations.

#### Unit 5: Responsible Living

In this final unit the concepts of value system, ethics, self-esteem and self-management are discussed in the context of family life.

#### **Prerequisites**

It is recommended that before you start commencing the study of this module, you become familiar with the first three core modules.

#### How long will it take?

It should take about 37 hours to work through this module. During this 37 hour period, besides studying the module, you should have also completed the various items provided in the units, such as, activities, case studies and self-help questions. All the units in this module are more or less of same length.

#### Learning tips

#### About this module

#### Activities, case studies and self-help questions

The activities, case studies and self-help questions are part of a planned distance education programme. It is important that you complete all these items during your coursse of study of this module to enable you to achieve competence in the learning outcomes stated at the beginning of this module. It is strongly recommended that you have a note book specifically for this purpose and keep a record of the progress of your study. - Stick to deadlines that you have set for yourself for completing your module. Also complete the assignments in time and hand them over to your study centre co-ordinator for evaluation. You should also receive your evaluated assignments from your study centre well before the term-end examinations and be satisfied that your answers are well received by the counsellor. You may also improve your answers based on the comments or suggestion made by your counsellor.
